2. Definition for the terms used.

g) **Member** : "Member" means the Member of **HIWARKAR ARTS, COMMERCE & SCIENCE COLLEGE ALUMNI ASSOCIATION.**

3) **Work Jurisdiction :**

Work area of the Institution will be in India & Union territories.

4) **Accounting Year :**

The accounting year of the Society shall be from the 1st of April to the 31st of March of the following year.

5) **Membership Subscription :**

An Indian adult, who has been the former student of **HIWARKAR ARTS, COMMERCE & SCIENCE COLLEGE ALUMNI ASSOCIATION**. And has obtained his/her degree from the said institute or Interns from the said institute and agrees in writing to be bound by the Memorandum of Association, regulations and bye-Laws of association and pays prescribed annual/life membership subscription and fees, as applicable, shall be eligible to become a member of **HIWARKAR ARTS, COMMERCE & SCIENCE COLLEGE ALUMNI ASSOCIATION**.

The executive committee reserves the right to accept / reject the membership application without assigning any reasons.

6. **Types of Members :** There shall be two types of members of this Society -

A) Life Member :- Person who contributes Rs. ⁵⁰⁰⁰~~1000~~/- ^{Denote} at once shall be life Member of the Society after acceptance of the Executive Committee, the membership of these life members shall last till their life.

B) Ordinary Member :- who contribute Rs. ²⁰⁰~~100~~/- ^{Denote} per annum only shall be the ordinary member of the Society after acceptance of Executive Committee. On failure to pay an amount of subscription before the expiry of said year of his/her membership, it shall result in automatic termination of his/her membership without any resolution to that effect. The members who lose their membership

for want of payment of the subscription in advance as stated above shall be eligible to apply for membership afresh.

7. Cancellation of Membership :



a) In the event of misconduct of activities detrimental or prejudicial to the interest of the Society or giving a go bye to the moral ethics on the part of the member of the Society, the Executive Committee of the Society shall convene a meeting for enquiry in the matter. The member against whom, the allegations as to any or all reasons as stated above are made shall be provided an opportunity to be heard in the said meeting and only for that purpose, that member shall have right to receive the notice and attend the meeting of the Executive Committee. On enquiry, if Executive Committee is satisfied by the explanations given by the member against whom, the enquiry is being conducted, the Executive Committee shall discharge the concerned member. If on completion of enquiry, the member is found guilty, Executive Committee may (i) terminate his/her membership (ii) suspend the same for the specific period (iii) debar the member to participate in particular function or functions (iv) impose penalty not exceeding Rs. 2,000/-. The decision taken in this regards by the Executive Committee shall be final and conclusive. If any member of the Executive Body / General Body is held guilty of any such guilt described above, and his membership shall be terminated/suspended by the Executive Committee; he shall be deemed to have ceased to be a member of the executive Committee/General Body, immediately after the result of an enquiry is declared by the Executive Committee, till he is enrolled as member again or his suspension remains into effect, as the case may be.

b) A member of the Society shall cease to be a member of the Society on his imprisonment on account of the verdict made by the Court of Law or tendering the resignation of membership are on account

of suspension, removal or termination of membership or on death of the member.

8. General Body Meeting its Powers and Functions :

The General Body meetings may be held as many times as is required for the achievement of the aims and objects of the Society. The General Body shall be Supreme Authority of the "Society". It shall have all those powers and shall perform all those functions which should have been performed respectively in furtherance of its aims and objects legally and which are not within the purview of the Executive Committee of the Society. A General Member who abstains himself from three consecutive General Body meeting of the Society or an

Executive Member who abstains himself from three consecutive Executive Committee Meetings without permission of the President, shall cease to be a member of the Society, on passing resolution to that effect by the Executive Body. The vacancy occurred in Executive Body shall be filled in from the members of the General Body of the Society, by majority decision of Executive Body.

9. Annual General Body Meeting

The General Body of the Society shall meet at least once in the year on the date, at the venue and at the time as is decided by the Executive Committee by issuing 15 days Clear Notice given to all General Body Members. This meeting shall be held preferably in the month of June or as may be decided by the Executive Committee. Business to be transferred in the Annual General Body meeting shall be :

- a) To confirm the minutes of last General Body Meeting.
- b) To consider and adopt the report on working of the Society prepared by the Secretary.
- c) To consider and to approve audited statements of accounts and balance sheet of the preceding financial year.



- d) To appoint or reappoint the auditors for the Society.
- e) To elect the office bearers/members amongst themselves for the Executive Committee.
- f) To transact such other business as demanded by the member of the General Body of the Society through requisition handed over to the Secretary at least 7 days in advance of the date of meeting.

10. Special General Meeting and its Functions :

The Special General Body meeting of the Society may be held to consider the urgent and/or important matters. This meeting may be called after 7 days clear notice only when $\frac{1}{4}$ the of the total alive members on roll require to call the said meeting to consider important issue in the interest of the Society. However, if the matter is of urgent nature, the notice of two days shall be sufficient. Clause No. 11 of the present bye-laws shall be applicable to these meetings so far as the Quorum is concerned.

11. Notice and Quorum for the General Body Meeting

$\frac{2}{3}$ of the total alive members on roll, whichever is less shall form the Quorum for the General Body Meeting. If the Quorum is not available on the given time and date, the meeting will be adjourned for 30 minutes. Even then, if the Quorum is not available, the members present shall form the Quorum, provided more than two members are present. The General Body Meeting shall be called only after issuing 15 days clear notice served through hand delivery and on refusal to accept, through Registered Post with A.D., by S.M.S. or E-mail, Whats App.



12. Executive Committee and its Office Bearers

- i) The Society shall have its Executive Committee consisting of 07 members to lead the Society towards achievement of its aims and objects. All members of the General Body shall have right to cast one vote. Elections shall be direct for each post in the Executive

Committee. The Executive Committee referred above shall be consisting of the office bearers and members as under :-

- A) President 1 Post
- B) Vice-President 1 Post
- C) Secretary 1 Post
- D) Joint Secretary 1Post
- E) Treasurer 1 Post
- F) Members 2 Post

13. Election

a) The Election of the Executive Committee of the Society will be held in Annual General Body Meeting after every **Five** years. All the members of the General Body shall be eligible to be elected and to vote in the Election of the Society.

b) The election of the Executive Committee shall be through the Majority by secret ballot method *Signature*

c) Every voter shall have right to cast one vote.

d) The election of the Executive Committee must take place in Annual General Body Meeting.

14. Tenure of the Executive Body

Tenure of the Executive Committee of the Society shall be of **Five** years.

However, if during the tenure of Executive Committee, the vacancy arises in it due to the death of member or resignation or termination of membership or otherwise, the surviving members of the Executive Committee may nominate by majority, any member to fill up the vacancy, for remaining period of completion of Tenure.

15. Powers and Functions of the Office Bearers of the Society

a) The office bearers of the Executive Committee shall also be the office bearers of the General Body.

b) Powers and functions of the Office Bearers of the Society shall be as follows :

1. President :- President shall preside over all meeting of the Society. The President shall look after the working of the society, and to do all the incidental act in the interest of the society. He is entitled to take emergent decision if any exigency arises, in the interest of the Trust.

2. Vice-President :- To perform the duty and work of president in his absence.

2. Secretary : The Secretary shall have charge and custody of all articles and record belonging to the society as a representative of the Executive Committee. He shall also be required to maintain all record of routine nature upto date. He shall be liable and entitled for issuing notices of the Meetings of the General and Executive Body of the society. He shall record the minutes of the meetings and maintain the proceeding book up-to-date. He will be liable for all sort of correspondence. He shall act as mouthpiece of the society for the public at large.



He will convey the suggestions of members of the Society to the President for the steps to be taken thereon, if any. He shall act in accordance with the directions issued by the President of the Society. He shall have charge and custody of the funds of the society. He shall be responsible for the proper provisions of information required by the Auditor appointed for the yearly accounts and submission of the audited accounts before the Annual general Meeting. He shall pay the dues of the society as per the directions of the Executive Committee. He shall manage the working

of the society to lead the same in furtherance of its aims and objects and do the needful for the same. All acts, intentions, dealings litigation and transactions for or against the society shall be expressed in the name of the Secretary. He shall be entitled to take emergent decisions in the interest of the society through emergent meeting of the Executive Committee.

4. Joint Secretary :- To perform the duty and work of **Secretary** in his absence.

5. Treasurer : To perform the duty of Treasurer and to maintain the income and expenditure account in consultation with the Secretary of the society. He/she shall have charge and custody of the funds of the society. He/She shall be responsible for the proper provisions of information required by the Auditor appointed for the yearly accounts and submission of the audited accounts before the Annual general Meeting.

Executive member :- To attend all meeting of the Trust. Share for the interest of the Trust and participate in Election.

16. Meeting of the Executive Committee There shall be two types of Executive Meetings :

Ordinary Executive Committee Meeting and Emergent/requisition Executive Committee Meeting.

A) Ordinary Executive Committee Meeting and its Notice :

Executive Committee shall meet at least once in two months, however there shall be no restrictions on the frequency of the meeting more than two. The Ordinary Executive Meeting may be called only after giving clear 7 days notice. Non-receipt of the notice will not vitiate the proceeding of the meeting of the Executive Committee provided the compliance of the conditions laid down in these rules/ regulations for service of notice is made.

B) Emergent / Requisition Executive Committee Meeting and its Notice:- On receipt by the Secretary requisition for an Emergent



Executive Committee Meeting signed by at least 4 members of the Executive Committee for consideration of the subject of urgent nature, such meeting may be called as Requisition Meeting. The Requisition Meeting shall be called by at least 7 days clear notice. Emergent Meeting shall be called by the Secretary of the Society to discuss any Emergent Agenda in consultation with the President with the notice of at least 24 hours. No transaction except that for which the Emergent or Requisition Meeting is called shall be dealt with in the said meeting. The requisition meeting will have to be called within 15 days from the receipt of the requisition.

17. Quorum for Executive Committee Meeting : 1/3 members shall form the quorum for the Executive Committee Meeting. If at the scheduled time, the quorum is not available, the meeting shall be adjourned for 30 minutes. Even then, if the quorum is not available, then the members present shall form the quorum provided they are at least 2 in number.

18. Conduct of business of Executive Committee Meeting

a) In case of division of votes on any specific issue, then on demand by any members, the members shall give their opinion to the President in writing secretly. If the votes are divided equally, the President shall have supreme voice in the matter and his decision on the issue shall be final and conclusive.

b) Meeting shall proceed in accordance with the directions of the Chair.

c) Resolutions passed in the meeting shall be followed immediately by notice of the minutes by the Secretary. The members present in the said meeting shall sign the minutes of all the meetings.

19. Powers and Duties of the Executive Committee

- a) Executive Committee shall have to manage the Society so as to lead the same towards the achievement of its aims and objects. For that purpose, it shall have all expressed legal powers and authority and also the implied power provided that the same does not contradict with the provisions of expressed powers herein, so also the existing provisions of law. The Executive Committee for that purpose will rely upon the collective decision taken by it in its meetings.
- b) The Executive Committee shall be responsible to the members of the Society for any loss caused to the Society due to its intentional negligence.
- c) The Executive Committee's Office bearers shall be liable for the performance of their duties as are described in Clause II above towards the proper functioning of the Society.
- d) To consider and approve the "Budget" for the current financial year.
- e) To fill up vacancies in Executive Committee.
- f) To enroll the members of the society.
- g) To cancel/terminate membership of any member.

20. If during the tenure of the Executive Committee, the number of Executive members is decreased due to diss-membership, death, and resignation or for any other reason, the remaining members shall fill up the vacancy by way of nomination from amongst the eligible members of the Society by passing the resolution to that effect. The tenure of the new member shall correspond with the remaining tenure of the said Executive Committee. While filling up the vacancy in this way, it shall not be binding upon the Executive



Committee to place that new member in the very post lying vacant, and he may be taken simply as member or other office bearer and reshuffling the Executive Committee member's Offices may fill in the actual vacant post.

21. Funds of Society

(A) Sources of the Funds : Following shall be the sources making funds available for the society :-

- i) Subscription received by the Society. Donations in Indian or Foreign Currency or in any other kind. Rent, Loan Deposits Contribution made by the members or Public at large on appeal made by the Executive Committee for the specific purpose. Proceeds of the sale of articles (movable or immovable property) Government grants.

(B) Society's Funds Entire funds of the society except as is provided in Clause 22 (A) above shall be deposited in the Bank Account in the name of the Society. These funds shall be available at the disposal of the Executive Committee for it's strict application towards the achievement of the aims and objects of the Society. However, if the Executive Committee deems fit or necessary, it may deposit the portion of the funds available with it in any of the Nationalized or Co-operative Bank as fixed deposit.



22. Loan and Deposits : The Society may obtain loan with due permission of the Jt. Charity Commissioner only in the interest of achievement of the objects of the Society. The Executive Committee may accept deposits from the members if the Executive Committee resolves so on such terms and the Executive Committee may decided conditions as.

23. Purchase and Sale of the Immovable Property: The Society may purchase, sale or take on lease immovable property when the

proposal to that effect comes before the Executive Committee and is converted into a resolution. On such resolution, the following conditions shall be followed at the time of purchasing / selling or taking on lease or exchange the immovable property i.e.

A) That the immovable property shall be sold, exchanged given in lease, purchased only in the name of the Society.

B) No immovable property shall be sold/purchased or given on lease, gift of exchange provided there is genuine cause for the same.

C) No immovable property shall be sold, gifted, exchanged, purchased with intention to make profit.

D) No immovable property shall be sold, exchanged or leased out without the prior permission of Hon'ble Joint Charity Commissioner, Nagpur as required under the provisions of the Bombay Public Trusts Act, 1950.

E) Each such transaction of sale/purchase/lease/exchange shall be made in the name of Society, which shall to be shown as acting through its President.

24. Bank Account

The Society shall have its Bank Account with the Nationalized ~~or~~ Gov. Recognized Post Office Bank only approved by the Executive Committee and the same shall be in the name of the Society only. This account will be operated with the joint signatures of any two out of the President, Secretary, Treasurer of the Society.

25. Register of Members

The Society shall maintain a "Register of Members" wherein, the details of the members of the Society shall be entered into category wise described in Clause 6 hereinbefore in accordance with the existing concerned provisions of law. Any change as to the address or other particulars immediately on occurrence should be conveyed to the Executive Committee by the Society members and the

Executive Committee shall be liable to carryout the suitable corrections in the "Register of Members" with immediate effect.

26. Amendment in Rules and Regulations

A) Any rules/regulations of the society may be amended by the resolution passed by Executive Body confirmed in the General Body Meeting by 2/3 of the total alive members on roll on the date of the meeting. Any addition to or deletion from the existing clauses in these rules and regulation may be made accordingly.

B) Name of the Society so also the aims and objects thereof may be altered in the manner provided in Sub-clause (1) above of this clause for the amendment in the rules and regulations.

27. Dissolution

A) The Society may be dissolved only through the resolution passed by at least 6th alive members present and voting in the General Body Meeting called on the date of the meeting called for the said purposed only as per the provisions of Sec. 13 and Sec. 14 of the Societies Registration Act, 1860.

B) If upon dissolution of the society and satisfaction of the debts and dues, there remains any property, the same shall be donated to the other society having objects similar to this society.

28. Irrevocability:- The institution hereby constituted shall be irrevocable.



29. Beneficiary is a section of the public and not a particular individual: Beneficiaries under the organization are the public sector and not specific individuals.

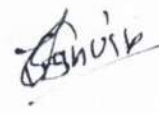

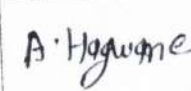
