

**Resolution No.2**



**Subject No. 5:** Making the grievance redressal system more effective and easier.


**Resolution No.5**

**Subject No. 8:** To submit an annual report after reviewing the Anti-Corruption Committee at the end of the session.


**Resolution No. 8**
